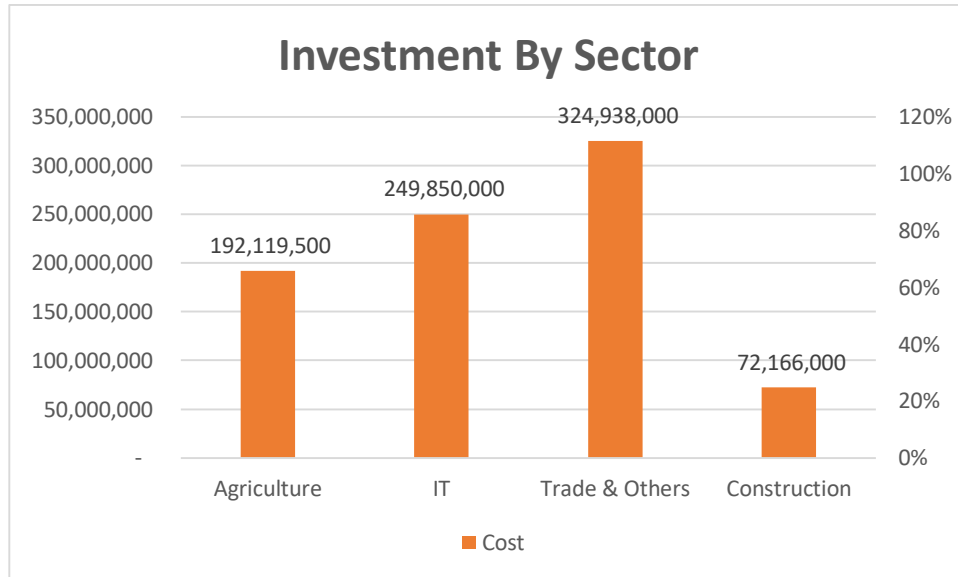

Sector Analysis



The problem we are solving/ customer problem is

Many people in Uganda are hardworking, struggling and succeeding to get LPOs, through their own hard work, or government affirmative action procurement in favour of the youth and women. However, having secured the contracts, they lack capital to finance the contracts, either due to lack of security, or due to lack of mandatory 3-years-in-business rule before they can access a loan, or both.

Our products offering is

1. A contract crowdfunding platform on web and mobile app that connects people who have (won) contracts to people who have money to finance the contracts; and
2. A pool of funds, capitalized by individual retail investors, investing as little as USD. 1,000, at interest rates of 3% per month, and **ContractKapital** in turn uses the funds to finance LPOs, tenders, contract farming, on short term, profit share basis without need for collateral.

Our innovation is unique because

We enhance financial inclusion, enabling people with contracts to access financing without collateral, without security, and without banking history, hence, creating financial inclusion. We also enhance focus on direct disbursement of funds to ensure contract is delivered without delays on side of entrepreneur. Further, most financing options require the youth applying to have collateral, or banking history, or experience in running a business, or all the above. Our opportunity is a profit share, short term joint venture, and hence, no need for those impediments.
