HOW DO YOU GET CONTRACTS TO FINANCE?

We have contract agents, free lancers visiting markets, garages, factories, malls, Facebook groups, Whatsapp groups, Telegram, Instagram, conferences, workshops, exhibitions, churches, schools, companies, to look for people who have secured orders to but lack capital and to negotiate long term strategic partnerships with key industries, government agencies, and factories.

HOW DO YOU RAISE CAPITAL TO FINANCE CONTRACTS?

We use direct marketing model, inviting investors who have invested with us to invite their friends, families, (FFs), clients and colleagues (CCs), to invest and enjoy the benefits of becoming millionaires.

HOW DO YOU SUPPORT AGENTS AND AFFILIATES?

Agents attend daily trainings facilitated and supported by the company. Agents print their own business cards and IDs. Agents are given flyers, booklets and stickers in hard and soft copy.

HOW DO YOU EARN FROM CONTRACT FINANCING?

We share gross profits margins equally with entrepreneurs for contracts financed.

HOW DO YOU COLLECT INVESTMENT AND PAY BACK INTEREST?

Our online platform accepts all payments, including crypto currency, credit cards, and mobile money. We pay back investors through bank transfer or mobile money transfer.

HOW MUCH INTEREST DO YOU PAY INVESTORS?

We pay investors 1% weekly; 6% monthly' 20% every 3 months; 45% every 6 months, or 100% in 12 months. Investors can take their money out after one year.

HOW DO YOU REDUCE RISK WHEN FINANCING CONTRACTS?

Our due diligence ensures legality, legitimacy and profitability; we pay direct to vendors; we supervise entire execution; and we control payment account through liening or receiving payment.

WHAT IS YOUR MINIMUM AND MAXIMUM INVESTMENT?

Minimum investment is USD. 30. There is not maximum investment.

HOW DO YOU SECURE INVESTOR'S FUNDS?

We offer land titles to investors who invest from USD. 10,000. Secured investors earn 3% per month. Unsecured investors earn 6% per month. One land title can be shared by various investors (title tokenization). Investors are invited to Telegram Channel and Whatsapp group to share their experiences. Investors also attend quarterly meetings to act as trustees.

HOW DO YOU UTILISE FUNDS INVESTED?

We utilize 14% for paying commissions to agents as marketing expense; we utilize 6% for administration and overheads; we utilize 80% in financing contracts.

HOW OLD IS THE COMPANY

We are in our fourth financial year of operations, with past three audited accounts, and our with licensing, registration certificates, and tax returns for both the company and directors are up to date.
