GO BIG INVESTMENT CONTRACT

1. PREAMBLE- GOBIGHUB CONTRACT FINANCING INVESTMENT

- 1.1 Welcome to GoBigHub.com, the place where investors become millionaires.
- 1.2 Our mission is to make you a millionaire within 5 years through financing contracts.
- 1.3 We believe that investment is a journey: you need to **set the destination** and **set the arrival time**.
- 1.4 We believe further that financial freedom is long term project, not a get-rich-quick scheme.
- 1.5 Michelle Obama wisely said, ***“Those of us who wanted to be rich quickly within one year found themselves in prison or dead within six months”***.
- 1.6 We finance legal, verifiable, and legitimate contracts on profit sharing, full supervision, direct disbursement, and no-collateral basis.
- 1.7 WHEREAS GoBig Finance and Mentorship Hub Limited (herein GoBigHub, and the term GoBigHub including the heirs, personal representatives and assigns), with physical address at GoBig House, Muwafu Road, Plot 8A, Ministers’ Village, Ntinda, Kampala, Uganda. P.O. Box 4215, made an offer to the investor to invest in gobighub; and
- 1.8 WHEREAS the investor, with name and address as below, (the term investor herein including the investor’s heirs, personal representatives and assigns) accepted the offer to invest in gobighub;
- 1.9 NOW, THEREFORE, GoBigHub and the Investor, (herein “the Parties”) mutually agree to enter into this financing contract under the terms as below.

4. USE OF FUNDS & ADMINISTRATIVE ISSUES

- 4.1 The purpose of the investment is to finance GoBigHub investments in contract financing including but not limited to invoice discounting, LPO financing, *ejusdem generis*.
- 4.2 GoBigHub utilizes part of the funds for operational expenses and overheads, including payment of commissions to agents and utilizes the balance for investing in contract financing.
- 4.3 Every party shall indemnify and hold harmless the other Parties from and against any and all claims, liabilities, damages and reasonable costs arising from any breach of this Agreement.
- 4.4 Each Party hereby warrants and represents to the other(s) that it has the right and capacity to enter into this Agreement.
- 4.5 Any payment made or received shall be receipted, and/or vouchers signed.
- 4.6 The investor may be required to show source of funds to prevent money laundering.
- 4.7 For transparency, and to address money laundering concerns, the investor shall receive monthly report of the contracts financed using their investment.
- 4.8 UGX. 10,000 shall be deducted as registration fees to GoBigHub Multi Purpose Cooperative, and UGX. 10,000 as fees for purchasing one share in GoBigHub Multi Purpose Cooperative.

5. DISPUTE RESOLUTION

- 5.1 This Agreement is interpreted and governed by the laws of Uganda and the parties hereby submit to the exclusive jurisdiction of the courts of the Republic of Uganda.
- 5.2 All disputes between the parties in relation to this agreement shall be resolved through negotiations between the parties, commenced with a written 'invitation to negotiate' by any of the parties.
- 5.3 If the dispute is not resolved within seven (7) days from the date of receipt of a written 'invitation to negotiate', the parties will in good faith refer the matter to mediation before resorting to litigation.
- 5.4 Provided that in the event of delays in payment to an investor, the investor shall be entitled to interest at the rate of 0.01% per day on the defaulting amount.

6. MINIMUM INVESTMENT AMOUNTS & RETURNS ON INVESTMENT

- 6.1 Minimum investment is UGX. 100,000 (Approx. USD. 30)
- 6.2 Minimum secured investment (with title) is UGX. 10,000,000 (Approx. USD. 3,000)
- 6.3 Unsecured investors earn 6% interest monthly.
- 6.4 Secured investors earn 3% monthly.
- 6.5 Investors who take their interest weekly earn 1%.
- 6.6 Investors who take their interest monthly earn 6%.
- 6.7 Investors who re-invest interest for 3 months earn 20%,
- 6.8 Investors who re-invest interest for 6 months earn 45%.
- 6.9 Investors who re-invest interest for 12 months double their money, compounding to 100% p.a.
